- 5. Corporate renewal annual report completed.
- 6. New dumpster surround completed at Building #5 and one replacement post at #4 surround
- 7. Confirmation of the fire extinguisher box inside the cabana does not require a cover as it is not subject to weather.
- 8. American Leak Detection sent out for water intrusion in building 4, units 414 and 424.
- 9. Condo questionnaire completed for #532
- 10. Notice mailed to owner regarding late fee waiver.
- 11. Termination of DirecTV notice emailed to MEREO Networks. More information to follow to owners.

## **RULE REMINDERS:**

Owners who abuse the dumpster will be billed back for the haul away per the Rules and Regulations.
